Overview

According to the announced results of BrandFinance, Turkish Airlines, our national flag-carrier airline of the Republic of Turkey, which was previously awarded this title in recent years, has been listed once again as "Turkey's Most Valuable Brand" in 2018, with a value exceeding \$2.0 billion.

Besides our superior products and services, many prestigious awards, granted by the leading institutions across the aviation industry recently, increased the brand awareness of Turkish Airlines. We, at Turkish Airlines, believe that this enhanced level of recognition paves the way for our Incorporation to become a five-star airline across Europe. While taking concrete steps to achieve this, Turkish Airlines was named as the "Five-Star Global Airline" in APEX Official Airline Ratings for 2018.

The Company has grown steadily with double-digit growth rates and has transformed into one of the largest global network carriers in the world.

As of December 2018, with the world's 4th largest flight network, Turkish Airlines flies to 306 destinations in 124 countries. This country coverage is greater than any other airline in the world.

Istanbul: A Natural Hub

Istanbul, as a transfer point on global routes, reduces flight time and introduces the flexibility to use a variety of aircraft of diverse capacity. Using Istanbul Ataturk Airport as a hub enables Turkish Airlines to utilize a narrow body fleet, thus providing a considerable cost advantage and

contributing to competitive superiority. Istanbul Ataturk Airport was the 4th busiest airport in Europe in 2018. According to ACI Europe Airport 2018 December Report, this ranking is likely to change in 2019 as growth at our new main hub Istanbul Airport is accelerating.

Fleet

As of December 2018, the number of aircraft in the Turkish Airlines fleet is 332 including 22 cargo aircraft, with an average fleet age of 8.2 years.

On March 9, 2018, in order to insure the need for wide body aircraft, the Incorporation has decided to purchase 50 firm and 10 optional aircraft, a total of 60 wide body aircraft to be delivered between 2019 and 2023. According to this, a total of 30 B787-9 aircraft, of which 25 firm and 5 optional, will be purchased from Boeing and a total of 30 A350-900 aircraft, of which 25 firm and 5 optional will be purchased from Boeing.

On March 15 and April 9, 2013, in order to insure the need for single-aisle passenger aircraft, the Incorporation had decided to purchase 92 A321 NEO and 75 B737 MAX aircraft from Airbus and Boeing. One A321 NEO aircraft and three B737-8 MAX aircraft of these order has been delivered in the third quarter of 2018. The rest of the purchase order is planned to be delivered until the end of 2023.

By the end of December 2018, the operation has been carried out by 92 double-aisle passenger aircraft, 218 singleaisle passenger aircraft and 22 cargo aircraft. Double-aisle aircraft constitute about 28 % of the total number of aircraft in fleet. Due to the effect of stage length and seat capacity, contribution of wide body aircraft to the



production is more than 50%.
