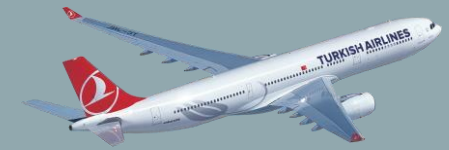
Important Environmental Aspects

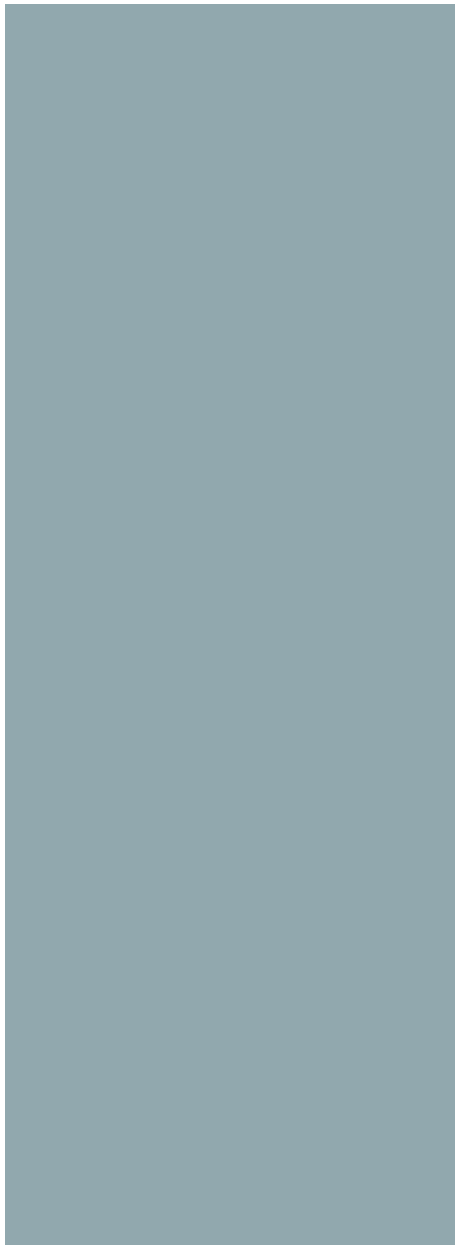
